<u>Financials:</u> Jim Berry presented the Financial report. Jim Berry brought out financials definitions by discussing funds available to the EDC of Hot Funds and General Fund.

Jim explained how he was handling the financial report to show how we could track the figures easier. No vote was taken.

New Business:

The Bassmaster tournament is moving forward, but it will not be as big as it has been in past years. We will be having a meeting on October 14th to finish up the tournament.

The Airport Appreciation dinner was canceled because of the Coronavirus Pandemic.

The Business Relief program is finished, and the checks have been sent to the recipients. The total dollar figure was \$103,850, with \$96,750 leftover from the UCC funds.

Neal Duncan demonstrated Committee Tracking Software. This is the Trello program to have all of our reports joined together. This will help us with our Strategic planning for Wood County. Information is beginning to be shared, and the various boards and cards will be available for the development of the Annual Report and the County Master Plan. The boards include the WCEDC function baseline and tracking goals with individual committee input. Also included is information on the HOT fund audit, business incentive program, and more.

The UCC application program will be looked at again and will be set up on a date in January.

Chairman's Report:

The report was incorporated with the Committee Tracking Software given by Neal Duncan.

Committee Reports:

Tom Callan brought in the Wood County District Clerk Donna Houston to give us an update on Criminal Dispositions for the last two years in Wood County for crimes of misdemeanors and felony cases.

Gwen Winters reported on her Health and Human Services Committee to set up a commission that will gather information to develop an online survey that will capture data from the entire Wood County for ongoing public health issues to improve the quality of life.

Lee Smith gave an update on his Infrasture & Transportation Committee and will present the first kickoff meeting on October 15th. Neal Duncan presented his meeting with UT Tyler with the East Texas Entrepreneurship Center and the Hibbs Business and Economic Institue to help with the WCEDC in future programs.
